

To: All Hardin County School Employees who participate in any Hardin County Schools Medical Insurance Plan

GOOD NEWS!

The Hardin County Schools Insurance Consortium is pleased to announce the Healthy Schools 2017 Points Incentive System. **Earn 33 points** and you will earn a \$175 health insurance premium credit or contribution to your Health Savings Account ("H.S.A."). If you are on a family plan, you and your spouse (maximum of \$350) are eligible.

Only 33 points to a Better You, same as last year! More opportunities added for 2017,

- a. The maximum points has been increased from 10 to 15 for item 6,
- b. Item 14.b. has been added.

How do I submit my points?

1. See the attached form for **19** possible areas to obtain points.
2. From November 1, 2016 to October 31, 2017, participate or complete any of the possible attached opportunities. Circle all applicable areas in which you participate and complete.
3. For all areas that you would like to receive credit, you must provide supporting documentation, including:
 - Flu Vaccine receipt from pharmacy or doctor
 - Signed non tobacco user affidavit, attached
 - Three (3) month printout for online fitness and calorie tracking (**SUMMARY REPORT ONLY**)
 - Wellness screening / mammogram / pap test, etc. EOB from Med Mutual or receipt from doctor. The EOB or receipt **MUST** state "mammogram" or "pap smear" or "colonoscopy" or "**PSA test**"
 - Dental / vision / physical exam receipt from doctor
 - Fitness event proof, minimum of a 5K, i.e. 5k receipt or **dated** bib or certificate
 - Weight Watchers receipts for at least 3 months.
 - Proof of Health Assessment on Medical Mutual website (www.mmoh.com), **1st page only**
 - ETC..... This list is not all-inclusive.
4. Total your points before October 31st. **Your documentation must be in order and numbered according to the point system sheet.**
5. Turn in your Point Opportunity Worksheet (with your total points) and all supporting documentation into your **Treasurer's Office by November 1, 2017. No past due packets will be accepted.**

Special Notes on Point Opportunities:

1. For #2, Participation in Health Screening Annually. If you participate in the Hardin County Health Screening at the School, no documentation is needed. The Treasurer will verify your points with the Hardin County Consortium.
2. For #10, Completion and proof of Health Assessment tool- MMO. This is a Health Assessment tool on the Medical Mutual website, www.medmutual.com. You will need to set up a MMO account for yourself and log-in in order to see Health Assessment at the bottom of the page under Quick Links. **After completion, only the first page should be printed.**

What happens after November 1st?

1. The Wellness Committee of the Hardin County Insurance Consortium will meet and verify all points.
2. Each participant that meets the 33 required points will receive \$175 health insurance premium credit in their December paycheck. (More money in your pocket at Christmas time!)
3. If you participate in the H.S.A., \$175 will be added to your Optum savings account in December or January as an employer contribution. (up to \$350 for both employee and spouse)

Do you have a suggestion for an additional healthy point opportunity? Please let your Treasurer's office know. We want this to be fun and easy to follow to save employees money and help improve the health and the overall well-being of all Hardin County school employees.
